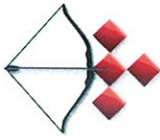

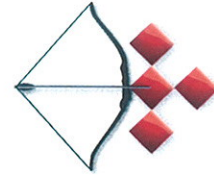

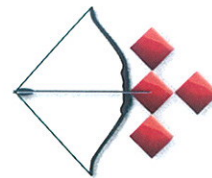
## PROTOCOL

### ON MUTUAL COOPERATION IN EDUCATION OF PERSONS QUALIFIED TO WORK IN ARCHERY

Based on the provisions of the Olympic Charter, especially Chapter III, paragraph 26 and 27 (Subparagraf 1.2) and Chapter IV, paragraph 28 (Subparagraf 2.2.1) of the Croatian Sport Act and a specially Article 9 and 60, in accordance with the Program of persons qualified to work in in sports as regards the realization of the Archery program described in Gazzete of Ministry of Science, Education and Sport of February 24<sup>th</sup> 2014., Signers established the following:

I

Croatian Olympic Academy together with CAA shall conduct the Program of training of persons qualified to work in sports for the needs of the Archery, in accordance with previously established Program, approved by Ministry of Education and Sport (Klass:



UP/I-602-07/14-03/00068, DocNo: 533-25-14-0002, from February 24<sup>th</sup> 2014.), and valid laws of the Republic of Croatia, according to the training standards of WA, which is being certified by the Signers hereof with their signatures hereon.

## II

The Croatian Olympic Academy shall issue a public document (Certificate of Education) after the report of the completion of the Course has been submitted, to all the persons who have completed Archery training under the conditions of paragraph I of this Protocol, as evidence of the degree of professional education in the sport of Archery and WA shall together with CAA issue a corresponding license.

## III

Signers shall, in accordance with their authorities and program needs, meet together all the conditions for the improving of professional work in Archery.

## IV

Signers are signing this Protocol in six (6) identical copies, Two (2) for each party hereof.
